Why FTA Application Portal & Login.gov training?

- To comply with the May 2021 executive order for improving our nation's Cybersecurity, FTA is transitioning to Login.gov for accessing FTA systems that require authentication. Once implemented, users will be redirected to Login.gov to access application(s)
- This training session will provide an overview of the FTA Application Portal, Login.gov account creation and authentication process
- FTA Application Portal will go live on October 3rd, 2021
- Broadcast email will be sent to users with the FTA Application Portal and the help page links after go live

What is FTA Application Portal?

- FTA Application portal is a web-based, secure method of accessing external applications using Login.gov multi factor authentication process
- In addition to the password, Login.gov uses the following authentication options to setup the secondary authentication:
 - PIV (personal identity verification) cards or CACs (common access cards)
 - Security Key
 - Authentication Application (e.g., Google Authenticator, Authy, LastPass, 1Password, Microsoft Authenticator)
 - Text Message/ Phone Call
 - Backup Codes



 - Charter Registration
 - Contact Us
 - Meeting Request Form



What is FTA Application Portal?

- FTA Application Portal allows users to
 - View and access already registered application(s)
 - Register to an application(s)
 - Reactivate application access after 60-day inactivity
 - View application access awaiting approval from FTA
 - View application access denied by FTA
 - Access application(s) without registration
